

## Privacy Policy

We at the West Seattle Chamber of Commerce respect your privacy and are committed to protecting your personal information. This privacy policy describes how we collect, use, and share information when you use the Visit West Seattle App (collectively, the "Service").

### Information We Collect

We may collect certain information about you when you use our Service, including:

- **Personal information:** We may collect personal information such as your name, email address, phone number, and other contact information that you provide to us when you register for an account, sign up for our newsletter, or otherwise use our Service.
- **Usage data:** We may collect information about how you use our Service, including the pages you visit, the links you click, and other actions you take.
- **Cookies and similar technologies:** We may use cookies and similar technologies to collect information about your device and how you use our Service. Cookies are small data files that are placed on your device when you visit a website. We may use both session cookies, which expire when you close your browser, and persistent cookies, which stay on your device until they expire or you delete them.
- **Log data:** We may collect log data when you use our Service, which may include your IP address, browser type, operating system, the referring web page, pages visited, location, your mobile carrier, device information (including device and application IDs), search terms, and cookie information.

### How We Use Your Information

We may use the information we collect about you for the following purposes:

- **To provide and improve our Service:** We may use your information to provide and improve our Service, to personalize your experience, and to develop new features and services.
- **To communicate with you:** We may use your information to communicate with you about our Service, to send you updates and notifications, and to respond to your requests and inquiries.
- **To analyze usage:** We may use your information to understand how our Service is being used, to analyze trends, to administer our Service, and to monitor and prevent fraud and abuse.
- **To comply with legal obligations:** We may use your information to comply with applicable laws, regulations, and legal processes.

### How We Share Your Information

We may share your information with third-party service providers that help us operate our Service and provide you with a better experience. We may also share your information in the following circumstances:

- With your consent: We may share your information with your consent or at your direction.
- For legal purposes: We may share your information to comply with applicable laws, regulations, and legal processes.
- In connection with a merger or sale: We may share your information if we are involved in a merger, acquisition, or sale of all or a portion of our assets.

## Security

We take reasonable measures to protect your personal information from unauthorized access, use, and disclosure. However, no data transmission over the internet or wireless network can be guaranteed to be 100% secure. Therefore, we cannot guarantee the security of your information.

## Your Choices

You can choose not to provide certain information to us, but this may limit your ability to use our Service. You can also opt out of receiving promotional emails from us by following the instructions in those emails. Please note that even if you opt out of receiving promotional emails, we may still send you non-promotional emails, such as those related to your account or transactions with us.
